

POLIJES 2024 REGULATION

PREMISE

These regulations govern the general criteria for admission and participation in the event called PoliJEs organized by Junior Enterprise Torino Politecnico and Junior Enterprise Milano Politecnico (from now on the "Organizers").

PoliJEs is intended to be a moment of sharing, training and personal growth, allowing participating students to get in touch with other Junior Entrepreneurs and with managers and experts from the entrepreneurial world, addressing issues of global relevance.

ART. 1 - OBJECT OF THE REGULATIONS

1.1 The present regulations define the terms and conditions under which the above-mentioned event shall be governed, specifying the rights and obligations of both the Participants and the Organisers.

1.2 The Participant formally undertakes to comply with the following details.

ART. 2 - PLACE, DATE AND TIMES OF THE EVENT

- 2.1 The PoliJEs will be held in Turin.
- 2.2 The event will take place on 12-13-14 April from 15:30 until 14:00.

ART. 3 - PARTICIPATION REQUIREMENTS

3.1 Participation requires the presence of the Participant for the entire duration of the Event.

- 3.2 Participants who meet the following requirements will be admitted to the Event:

- Registration via the website <u>www.polijes.com;</u>
- Payment of the participation fee according to the terms and conditions set out in the previous regulations.

3.3 The Organizers reserve the right to identify, according to their free discretion, persons to be recognised as participating in the Event if they do not meet one or more of the above-mentioned requirements.

3.4 The maximum number of participants in the Event is set at 13 Junior Entrepreneur per JE, including the President or his/her delegate of the JE attending the Presidents' Meeting. For the Organisers, staff are to be excluded from the number of Junior Entrepreneurs admitted.

3.5 Should the maximum number of participants not be reached, the organizers reserve the right to distribute the remaining free places, according to a chronological criterion and aim at giving equal space to each JE.

ART. 4 - EVENT REGISTRATION

4.1 Registration for the event can be made from 16th February 2024 at 15:00 to 8th April 2024 at 24:00 in the following ways:

- Registration via QR and Gomry platform.

Every part of the form marked as compulsory must be filled in with the required data, otherwise part of the requirements for participation in the event will not be met.

The Organisers' Staff reserve 7 days from receipt of the form to point out any compilation errors.

ART. 6 - PAYMENT METHODS

ART. 7 - WITHDRAWAL AND ASSIGNMENT OF THE CONTRACT

7.1 The right of withdrawal is excluded in this case, in accordance with the provisions for services concerning leisure activities pursuant to art. 16 letter l) Directive 2011/83/EU.

7.2 By and no later than 31 March at midnight, it is possible to transfer the contract to another person, notifying this in good time by email to <u>info@polijes.com</u> and subject to written authorisation sent in response by the event's Project Manager's delegate for registrations.

7.3 The Organizers are not liable for the assignment of the contract. In particular, the Organisers are not liable for the economic and/or event participation rights obligations undertaken by the parties to each other..



ART. 8 - ABSENCE

8.1 If the Participant, for any reason whatsoever, is unable to attend the scheduled meetings or, if for reasons of force majeure, is late on the day of the event, he/she must promptly notify the Organisers at info@polijes.com.

ART. 9 - RULES OF CONDUCT

9.1 Each Participant undertakes to conduct himself/herself throughout the event in a manner consistent with the customs and nature of the activity

9.2 Each Participant undertakes to take an active part in the event by respecting the defined timetables and the instructions given by the organizer.

9.3 Each participant undertakes to respect the dress code established by the organizers.

ART. 10 - RESPONSIBILITY

10.1 Each participating Junior Entrepreneur assumes all liability in the event of breakage and/or damage to goods belonging to the participants in the event attributable to him, even if only by way of slight negligence, including but not limited to: bags, clothing, backpacks..

10.2 The Organizers release themselves from any obligation to pay compensation of any kind by way of damages, indemnities, refunds, connected with the event.

ART. 11 - APPLICATION OF THE REGULATIONS

11.1 The Organizers reserve the right to make amendments to these regulations, notifying all those concerned by means of information circulars, which shall become an integral part of these regulations.

11.2 In the event of a breach of these regulations, the Organisers may take a measure to expel the Participant. In such an eventuality the latter shall not be entitled to any reimbursement or compensation.

11.3 In any case, the Organisers reserve the right to claim compensation from the offender for any damage suffered.

Art. 12 - JURISDICTION

12.1 By registering via the dedicated form referred to in art. 3 of these regulations, the Participant has accepted without reservation all the clauses of these regulations. Any dispute shall be governed by Italian law and the Court of Turin shall have jurisdiction.
